

## **PENALTY PROCEDURE**

The New Stateline Speedway Busti, New York is a professional organization and will conduct itself so in its dealings with everyone, including Fans, Drivers, Team Members, Track Sponsors, Team Sponsors. The Speedway therefore expects the same from its Drivers, Team Members and Team Sponsors. The Speedway and officials therefore reserve the right to take disciplinary action against anyone who brings the Track into disrepute by their actions, either on or off the track. Please remember that we are here because of the fans & sponsors. If they don't benefit...we won't. While we understand that this competition involves substantial financial stakes, there is no excuse for bad or unruly behavior. **Any type of aggressive or retaliatory driving will not be tolerated.** DRIVERS and/or OWNERS ARE RESPONSIBLE FOR ALL CREW/TEAM MEMBERS. Disciplinary action may also include, but is not limited to, the right of the track and officials to suspend either temporarily, or permanently, owner, any driver, team member or team sponsor whose actions, in the sole opinion and discretion of the track and officials, may have resulted in, or may result in, harm or detriment to the New Stateline Speedway Busti, New York. Points and Monies won will be FROZE for the night until the situation is resolved, generally by Tuesday after the race.

Any person caught entering the speedway grounds without paying will be asked to pay the entry fee immediately, failure to do so will require security and local authorities to be called to take legal action. Any driver/owner, team or individual participating in and/or helping someone gain entry to the Speedway without paying will be fined \$100.00 per person. There is ZERO tolerance.

Anyone caught driving on the racing surface after hours will be fined and banned from the Speedway for 1 year (365 days).

**ONLY THE DRIVER OF THE TOW VEHICLE SHALL BE ALLOWED TO ENTER THE PITS IN THE VEHICLE, ALL OTHERS MUST EXIT VEHICLE. PRIOR TO PIT ENTRY, A SPEEDWAY EMPLOYEE SHALL DO AN INTERIOR INSPECTION OF EACH VEHICLE AND TRAILER. FAILURE TO COMPLY OR AN INFRACTION ENRTY WILL BE DENIED**

Fighting will not be tolerated on or off the track, your actions may affect an innocent party. Owners/Drivers are responsible for their crew/sponsors actions in the pits.

**First offense-** any driver/owner or team member **going to a different pit with any physical contact in the pits** will be on probation for 4 weeks, given one week off and/or a fine depending on severity, which is payable before driver is able to resume racing after suspension. Fines range from \$100.00 to \$1,000.00. Monies won and points for that night will also be forfeited.

**Second offense** within a year (365 days)- any driver/owner or team member **going to a different pit with any physical contact in the pits** will be on probation for 3 months, given three weeks off, a 50 point deduction in yearly points and a fine, which is payable before driver is able to resume racing after suspension. Fines range from \$100.00 to \$1,000.00. Monies won and points for that night will also be forfeited.

**Third offense** within one year (365 days)- any driver or team member **going to a different pit with any physical contact in the pits** will be on probation for 1 Year, given a one year suspension, a 250 point deduction in yearly points, NO point money for the year will be awarded and a fine, which is payable before driver is able to resume racing after suspension. Fines range from \$100.00 to \$1,000.00. Monies won and points for that night will also be forfeited.

**ON TRACK: Aggressive and retaliatory driving will not be tolerated.** If this is observed under caution you will be black flagged from the race and/or the rest of the night. Depending on the severity could result in a fine, any points and money won for the night may also be forfeited. During racing conditions if it is deemed intentional or aggressive you will be black flagged, disqualified for that event, failure to leave the speedway may result in disqualification for the remainder of the night. Failure to follow the direction of the flagman or an official will result in DQ from that event, and/or a fine/suspension. **AGGRESSIVE OR RETAILITORY ACTIONS HAPPENING IN THE PITS WILL BE AUTOMATIC SUSPENSION FROM THAT EVENINGS RACING EVENTS, IF IT IS DEEMED SEVERE ABOVE PENALTIES WILL BE IN PLACE. ZERO TOLERENCE**

It is at the judgment of the Track and Officials if the offense is more severe, penalties can and may be more severe including but limited to banning an individual from the Speedway for a period of time. Any individual that continually causes problems, fighting or such, can and will be banned from the Speedway for a period of one year to lifetime ban depending on the severity of the offense. At any time Local Authorities may be called to handle situations.

**TECH:** Any Tech results deemed ILLEGAL will freeze any points or monies won for the night until all findings can be verified, generally by Tuesday but certain aspects may take longer (Tire test, etc...) Any driver failing chemical tire test will be fined \$500.00 and lose points and money won for the night, two week suspension, be put on 1 year probation (365 days from infraction) and lose 100 points from the yearly total. Crate Motor: any crate motor, 602 or 604 deemed illegal will be fined \$500.00, 1 year suspension from competition(365 days from infraction), loss of points and monies won from the night, and the loss of all yearly points and point award pay.

**NO DRIVER WHO HAS A FINE LEVIED ON THEM WILL NOT BE ALLOWED TO COMPETE UNTIL ALL THE FINES HAVE BEEN SATISFIED.**
