

# PENALTY PROCEDURE

The New Stateline Speedway Busti, New York is a professional organization and will conduct itself so in its dealings with everyone, including Fans, Drivers, Team Members, Track Sponsors, and Team Sponsors. The Speedway therefore expects the same from its Drivers, Team Members and Team Sponsors. The Speedway and officials therefore reserve the right to take disciplinary action against anyone who brings the Track into disrepute by their actions, either on or off the track. Please remember that we are here because of the fans & sponsors. If they don't benefit...we won't. While we understand that this competition involves substantial financial stakes, there is no excuse for bad or unruly behavior. **DRIVERS and/or OWNERS ARE RESPONSIBLE FOR ALL CREW/TEAM MEMBERS.** Disciplinary action may include, but is not limited to, the right of the track and officials to suspend either temporarily, or permanently, any owner, driver, team member or team sponsor whose actions, in the sole opinion and discretion of the track and officials, may have resulted in, or may result in, harm or detriment to the New Stateline Speedway Busti, New York. During any dispute a driver, owner, or crew member who is not in their own pit will be considered at fault. Points and monies won for the night will be frozen until the situation is resolved.

1. **PIT ENTRY - ONLY THE DRIVER OF THE TOW VEHICLE SHALL BE ALLOWED TO ENTER THE PITS IN THE VEHICLE.** All others must exit the vehicle and sign in, including the car number they are with, prior to pit entry. A speedway employee may do an interior inspection of each vehicle and trailer. Failure to comply will result in entry being denied. Any person caught entering the speedway grounds without paying will be asked to pay immediately, failure to do so will require security and local authorities to be called. Any individual participating in illegal entry and/or helping someone gain entry to the Speedway without paying will be fined \$100.00 per person. There is ZERO tolerance.
2. Anyone caught driving on the racing surface without permission will be fined/banned from the Speedway for 1 year.
3. Using Alcohol or Drugs: Any driver with a noticeable amount of alcohol or drugs present will not be allowed on the track
4. Failure to follow the direction of or any abusive physical or verbal altercations with the flagman or any other official will result in disqualification from that event, a one week suspension, and a possible fine.
5. Fighting will not be tolerated on or off the track. If any driver, owner or team member goes to another car or pit without an official and/or causes any physical contact with anyone, they may be fined from \$100.00 to \$1,000.00 depending on severity. Money and points for that night will be forfeited. **Additional suspensions/penalties** will occur as follows:  
**First offense** - on probation for 4 weeks, given one week off.  
**Second offense** - on probation for 3 months, given three weeks off, a 50 point deduction in yearly points  
**Third offense** - on probation for 1 Year, given a one year suspension, a 250 point deduction in yearly points, NO point money for the year will be awarded.
6. Aggressive and retaliatory driving will not be tolerated. If this is observed under caution or in the pits you will be black flagged from the race and/or for the rest of the night. If intentional aggressive driving is observed during racing conditions you will be black flagged and disqualified for that event. Failure to leave the speedway may result in disqualification for the remainder of the night. Drivers doing spin outs or speeding in the pits will not be allowed back out on the track. Depending on the severity, the above actions could also result in a fine, points, and money won for the night being forfeited.
7. Driving a car without registering both the car and driver will result in a one-week suspension.
8. Crew members entering the track during race conditions, including cautions, will result in disqualification from that event.
9. If a car leaves the racetrack it may not re-enter the racetrack under green flag conditions, doing so will result in disqualification from the event.
10. Leaving tires at the track will forfeit any money and points won that night.
11. Not making required changes to a car by the specified time will result in disqualification from that event.
12. Leaving any racecar on the track or taking a car back onto the track after the races are over will result in a one-week suspension.
13. **TECH:** Any Tech results deemed ILLEGAL will freeze any points or monies won for the night until all findings can be verified. Any driver failing a chemical tire test will be fined \$500.00 and lose points and money won for the night, two week suspension, be put on 1 year probation (365 days from infraction) and lose 100 points from the yearly total. **Crate Motor:** any crate motor, 602 or 604 deemed illegal will be fined \$500.00, 1 year suspension from competition (365 days from infraction), loss of points and monies won from the night, and the loss of all yearly points and point award pay.

It is at the judgment of the Track and Officials if the offense is more severe, penalties can and may be more severe including but not limited to banning an individual from the Speedway for a period of time. Any individual that continually causes problems, may be banned from the Speedway for a period from one year up to a lifetime depending on the severity of the offense.

**At any time Local Authorities may be called to handle situations.**

**Any driver who has a fine levied on them will not be allowed to compete until ALL fines are satisfied.**
